Grassing required by the work shall be performed by a contractor or subcontractor prequalified for work class Grassing – Seeding and Sodding (12) by the Florida Department of Transportation. Bids shall be on a unit price basis as indicated in the Bid Form. All terms, specifications and conditions set forth in this ITB are incorporated into your response. A bid will not be accepted unless all conditions have been met.
