

**OKALOOSA BOARD OF COUNTY COMMISSIONERS

ITB PW 75-19 JAMES LEE PARK PARKING LOT IMPROVEMENTS**

Notice is hereby given that Sealed Bids for the construction of the James Lee Park Parking Lot Improvements ITB PW 75-19 will be received by Board of County Commissioners of Okaloosa County at the Okaloosa County Courthouse, Room #282, 101 E. James Lee Blvd., Crestview, FL until **03:15 PM (CST) on September 18, 2019** at which time the Bids received will be publicly opened and read. No bids will be received after the designated time. The project Base Bid includes the expansion of the existing parking lot by approximately 7' and then mill and overlaying the proposed parking spaces to convert the parking on the north side of the lot from parallel parking to 45 degree parking and will be performed in two phases. The Additive Bid Alternate adds the mill and overlay of the remaining parking lot and the restriping of the entire parking lot. The scope includes full marking and landscape improvements. The work is further defined as shown on the Plans and as described by the Contract Documents.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form. All terms, specifications and conditions set forth in this ITB are incorporated into your response. A bid will not be accepted unless all conditions have been met.

Bid Documents may also be viewed at Okaloosa County Purchasing, 5479A Old Bethel Rd., Crestview, FL 32536. No printed copies of the bidding documents will be issued.

Bid security shall be furnished in accordance with the Instructions to Bidders.

A mandatory pre-bid conference will be held at 10:00 **AM (CST) on September 05, 2019** at the Okaloosa County Public Works Office, 1759 S. Ferdon Blvd., Crestview, FL.

All bids must be received in sealed envelopes reflecting on the outside thereof the Bidder's name and James Lee Park Parking Lot Improvements ITB PW 75-19. Any Bidder failing to mark outside of the envelope as set forth herein may not be entitled to have their bid considered. Okaloosa County is not responsible for lost or late delivery of bids by the U.S. Postal Service or other delivery services used by the respondent. Neither faxed nor electronically submitted bids will be accepted.

The Okaloosa BCC reserves the right to award the bid to the lowest responsive, responsible Bidder and to waive any irregularity or technicality in bids received. Okaloosa County shall be the sole judge of the bid and the resulting negotiated agreement that is in its best interest and its decision shall be final. Bids may not be withdrawn for a period of sixty (60) days after the bid opening unless otherwise specified.
