Submissions shall be portrait orientation, unbound, and 8 ½" x 11" where practical. All originals must have original signatures in blue ink.

A mandatory pre-bid conference is scheduled for 9:00 a.m. (CST), September 4, 2019. The conference will be held at the 3rd Floor of the Okaloosa County Water & Sewer Administration Building, Small Conference Room, 1804 Lewis Turner Blvd, Fort Walton Beach, Florida, 32547. You must attend this pre-bid conference for your bid to be considered responsive.

At 3:00 p.m. (CST), September 18, 2019, all bids will be opened and read aloud. All bids must be in sealed envelopes reflecting on the outside thereof the Respondent's name and "Sanitary Sewer Service Connection". The Board of County Commissioners will consider all bids properly submitted at its scheduled bid opening located at 101 E. James Lee Blvd, Crestview, FL 32536 Room 282. Bids may be submitted in the Room #282 prior to bid opening or delivered to the Okaloosa County Crestview Courthouse, 101 E. James Lee Blvd., #282, Crestview, FL 32536. *NOTE: MUST RING DOORBELL TO GAIN ENTRANCE INTO ROOM 282. THE CLERK WILL COME ACCEPT YOUR PACKAGE OR SHOW YO TO THE CONFFERNCE ROOM FOR THE SCHEDULED BID OPENING.
